KELLER WILLIAMS FLAGSHIP OF MARYLAND SIGNS 24,000 SQUARE FOOT LEASE WITH ST. JOHN PROPERTIES AS INAUGURAL TENANT AT 231 NAJOLES ROAD

Approximately 400 licensed real estate agents to work from new location in Millersville

BALTIMORE (November 14, 2017) – Keller Williams Realty, Flagship of Maryland, the local affiliate of the largest real estate franchisee in the country by agent count, has signed a new lease with St. John Properties, Inc. for nearly 24,000 square feet of space within 231 Najoles Road at the I-97 Business Park in Anne Arundel County. Representing the inaugural tenant in the five-story, 126,500 square foot Class "A" office building, which was delivered this summer, 400 licensed real estate agents are expected to work from the location. Keller Williams is occupying portions of the first and second floor and recently moved into its new space. Previously Keller Williams had been located at 1111 Benfield Boulevard, a two-story office building within the I-97 Business Park.

The project is within close proximity to Interstates 97, 695, and 95 as well as MD Routes 295 and 32, providing rapid connections to Annapolis, Columbia and Baltimore as well as Baltimore-Washington International Airport. Free parking is available throughout the business park and the immediate area is serviced by numerous business amenities including fast-casual and sit-down restaurants, retail centers and hotels.
